SELECTION POLICY

DIVISION I : INTRODUCTION

Selection Policy

1. This Australian National University Cricket Club (**ANUCC**) Selection Policy (**Selection Policy**) is an ANUCC Rule made under Division VI of the Australian National University Cricket Club Constitution.

Application

2. This Selection Policy applies to the selection of ANUCC Members to represent the ANUCC in all men's and women's Matches in which the ANUCC participates.

DIVISION II : SELECTION COMMITTEE

Establishment of a Selection Committee

3. Each season, the Committee of the ANUCC (**ANUCC Committee**) will establish a Selection Committee under Division VI of the Australian National University Cricket Club Constitution, comprising:
 - (a) a chair (**chair of selectors**);
 - (b) a men's ANUCC coach;
 - (c) a women's ANUCC coach or captain and
 - (d) at least one and no more than 3 other members that are captains of or senior players in an ANUCC team.

Role of the Selection Committee

4. The Selection Committee will select sides of eligible ANUCC Members to represent the ANUCC in all Matches in which the ANUCC participates.
5. The Selection Committee will meet at the times it considers necessary to select sides.
6. All members of the Selection Committee must participate in the selection of all sides being selected at a meeting and will be in attendance for the entire duration of the meeting.
7. Decisions relating to selections will be made by consensus (i.e. members are satisfied with the decision even though it may not be their preferred decision) and if consensus is not reached within a reasonable time in the circumstances, the chair of selections will make the decision.
8. The Selection Committee may invite any person to assist it perform its role under clause 4, but that person is not a member of the Selection Committee.

DIVISION III : ELIGIBILITY FOR SELECTION

9. The ANUCC Committee will provide the Selection Committee with a list of ANUCC Members eligible for selection to represent the ANUCC in Matches before the commencement of the season, and will update that list from time to time, as required.
10. The ANUCC Committee will inform the Selection Committee of any ANUCC Member who has become ineligible for selection in a Match or Matches because that Member:

- (a) is ineligible for selection because of a decision or ruling under the rules of a Competition or Association in which the Match is or Matches are to be played; or
 - (b) has not paid their Fees as required by the Committee or any other moneys due to the ANUCC; or
 - (c) has been suspended from eligibility for selection by the ANUCC Committee under clause 68 of the Australian National University Cricket Club Constitution.
11. The Selection Committee will select sides for a Match in accordance with any eligibility rules of the Competition or Association in which the Match is to be played.

DIVISION V : SELECTION OF SIDES

Selection criteria

12. In performing its role under clause 4, the Selection Committee may take into account:
- (a) the ANUCC's objectives for the side being selected;
 - (b) an ANUCC Member's current and previous form and ability;
 - (c) the availability of an ANUCC Member for selection, that ANUCC Member's availability history.
 - (d) an ANUCC Member's training attendance, participation and attitude;
 - (e) the development of the ANUCC as a competitive cricket club generally and the player development of individual ANUCC Members;
 - (f) the structure and composition of each side being selected;
 - (g) any finals eligibility rules for each side being selected; and
 - (h) any other factor that the Selection Committee reasonably considers relevant in the circumstances.

ANU students will be provided with priority over other Member's if all other factors are equal

Notification of selections

13. ANUCC Members will be notified of their selection or non-selection in a side to represent the ANUCC in a match by a member of the Selection Committee in the manner determined by the Selection Committee.
14. The Selection Committee will endeavour to provide notification of selections under clause 9 at least 2 days before the match.
15. The Selection Committee may make changes to selected sides for a Match at any time up to the commencement of that match and will endeavour to provide as much notice as possible of any such changes to affected ANUCC Members.

DIVISION IV : ANUCC MEMBER RESPONSIBILITIES

Unavailability

16. An ANUCC Member who is eligible but unavailable for selection in a match in which the ANUCC will participate must give the chair of selectors notice of their unavailability by midday of the Tuesday before the Match (unless informed otherwise by the chair of selectors or exceptional circumstances exist) in the manner determined by the Selection Committee.

Responsibilities

17. Any ANUCC Member who is selected to represent ANUCC in a match must:
 - (a) make themselves aware of the side that they have been selected in;
 - (b) make themselves aware of the Captain of that side's requirements, including as to punctuality and attire; and
 - (c) play in the side that they have been selected in.
